

# IJGlobal Awards 2021 – Europe & Africa shortlist

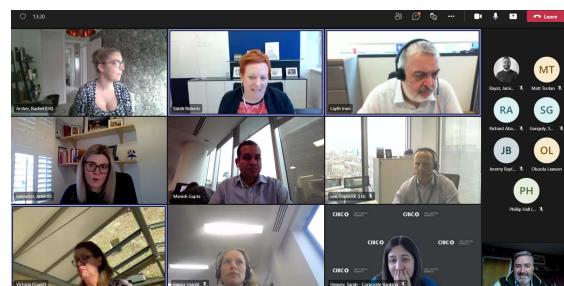
